





# **FIRE PREVENTION AND PUBLIC EDUCATION**

The Falmouth Volunteer Fire Department Office of Fire Prevention and Public Education are dedicated to reducing the number of fire deaths and injuries to the general public by increasing public education. Fire prevention staff continued developing close relationships with schools, churches, community groups and businesses in the Falmouth community to deliver classes on fire safety related topics.

The fire prevention staff continued efforts with the Free Smoke Detector Program, which was implemented in November 1999, trying to provide free smoke detectors to all Falmouth residents. Also, to meet the department's Strategic Plan of "Creating Safer and Healthier Neighborhoods." This continuous effort allowed our department to install sixteen smoke detectors in homes this year and twenty-one batteries were provided to residents for existing smoke detectors.

The fire prevention staff implemented a customer service enhancement program in August of 2003 through development of a customer satisfaction survey mail out for all services provided by the department (Fire/EMS/Prevention). This program allows us to gather feedback so we can exceed the community needs and provide the fire/rescue services that are desired by our customers. One hundred and twenty customers received our survey over the last year; all responses were compiled and portrayed to the membership.

Fire prevention staff coordinated with the Stafford County Department of Social Services for the Thanksgiving and Christmas "Adopt a Family Program". The department supported two families for Thanksgiving and provided gifts and dinner for four families during the Christmas Holiday. We will continue this effort this upcoming holiday season providing assistance to two families for Thanksgiving and two families during Christmas. The funding for these assistance programs are made possible by the extra efforts from the bingo staff that promote and conduct special fundraisers, allowing our department to provide a wonderful holiday for families in our community.

The fire prevention office researched and provided guidance on major events in the community. An incident action plan for the Rappahannock River Raft Race was republished this year, providing a vision on all aspects and situations of this event. Staff also coordinated with the Stafford County Emergency Management Division to develop IAP's for the Sheriff's Department Annual Dare Day Event and the July 4<sup>th</sup> Festivities. All assistance provided to the community groups made impacts in the overall safety and outcome of the events.
